**RESOLUTION**

No.35541500162018- 1256 /PE, Bhubaneswar, Dated. 23.04.2018

**Sub:- Payment of Honorarium and other allowances to the Non-Official Chairman of State Public Sector Undertakings.**

In partial modification of Public Enterprises Department Resolution No.Cor-I-74/2011-4810/PE, Dated.22.12.2011, Government have been pleased to decide that the Non-Official Chairman of State Public Sector Undertakings shall be entitled to Honorarium and Allowances as detailed below:

- (a) Honorarium / Salary: The Non-Official Chairman of State Public Sector Undertakings, which have made profit for two years out of last three years with positive Net worth (Category-A) shall be entitled for a fixed Honorarium of Rs.45,000/- (Rupees forty five thousand) only per month. The Non-Official Chairman of State Public Sector Undertakings who have not qualified the above criteria (Category-B) shall be entitled for a fixed Honorarium of Rs.30,000/- (Rupees thirty thousand) only per month.
- (b) Rent for Residence: The Non-Official Chairman of State Public Sector Undertakings shall be provided with rented accommodation with maximum plinth area of 2000 Sq. Ft. and the rent shall be limited to Rs.20,000/- (Rupees twenty thousand) only per month for category-"A" and Rs.15,000/- (Rupees fifteen thousand) only for category-"B" per month. If the spouse of the Non-Official Chairman is availing residential accommodation/ house rent from any other Undertakings/Government then he/she may avail either the facility availed by his/her spouse or the facility mentioned above.
- (c) Travelling Allowances: The Non-Official Chairman of State Public Sector Undertakings shall be entitled for TA & DA as applicable to Sr. Class I officials of the concerned Public Sector Undertakings.
- (d) Medical Allowances: The Non-Official Chairman of State Public Sector Undertakings shall be entitled for Medical Allowances as applicable to the Senior Class-I officials of the Concerned Public Sector Undertakings.
- (e) Conveyance Allowances: The Non-Official Chairman of State Public Sector Undertakings shall be provided with Conveyance facilities as follows:
  - i) For commuting from Office and back using the Public Sector Undertaking Vehicle:- Rs.1,680/- (Rupees One thousand and six hundred eighty) only will have to be paid by the Chairman.
  - ii) For using the Public Sector Undertaking Vehicle for private purpose up to 300 Kms per month:- Rs.2,520/- (Rupees Two thousand and five hundred twenty) only will have to be paid by the Chairman.
  - iii) For using the Public Sector Undertaking Vehicle for private purpose up to 500 Kms per month:- Rs.4,200/- (Rupees Four thousand and two hundred) only will have to be paid by the Chairman.
- (f) Entertainment Allowances: The Entertainment Allowances for the Non-Official Chairman of each State Public Sector Undertakings shall be limited to Rs.4,000/- (Rupees four thousand) only per month.

(g) Telephone facilities: The financial limit for monthly telephone bill of the Non-Official Chairman shall be limited to Rs.5000/- (Rupees five thousand) only for both office and residence including mobile phone.

2. This Resolution shall be applicable to the Statutory Corporations, Corporation registered under the Companies Act, Corporation registered under the Cooperative Societies Act, Boards etc. having Non-Official Chairman.

3. This shall come into effect from the date of issue of this Resolution.

ORDER: Ordered that the Resolution be published in an Extra-ordinary Issue of the Odisha Gazette and copies be supplied to all concerned.


