Sub: Fixation of Pay of Functional Directors for the State PSUs of Odisha.

At present the Functional Directors of Odisha State Public Sector Undertakings are recruited in the pay scale of Rs.37,400 - Rs.67,000/- with Grade Pay of Rs.9,000/- Per Month in Pay Band-4 under ORSP Rules,2008.


After considering the qualification, work experience and responsibilities of functional Directors in Odisha State Public Sector Undertakings, Government have been pleased to fix their initial pay at Rs.60,000/- with Grade Pay of Rs.9,000/- Per Month in Pay Band-4 against the Scale of Pay of Rs.37,400 - Rs.67,000/- under ORSP Rules, 2008 for the existing and future recruits of functional Directors of the State Public Sector Undertakings from the date of their joining.

Since the 7th Pay Commission has been implemented for the employees of the Government of Odisha as well as for the State Public Sector Undertakings w.e.f 01.01.2016, the Revised Pay Scale under ORSP Rules, 2017 will also be applicable for the existing and future recruits as per provisions of the Revised Pay Structure under ORSP Rules, 2017 at level-17 vide Finance Department Resolution No. 26342 dated 07.09.2017.

Accordingly, the revised scale of pay of each individual Director would be calculated on case to case basis as per the applicability of 6th or 7th pay commission for the relevant period.


