#### 1. Company profile

Odisha Power Transmission Corporation Limited (OPTCL), a state owned power utility organization in Odisha is engaged in the business of transmission of electricity with a vision to emerge as one of the leading utilities in the country in Transmission space. OPTCL is also discharging the functions of State Load Despatch Centre.

The State Load Despatch Centre is the apex body to ensure integrated operation of the power system in the state of Odisha. Its registered and Corporate Office is at Bhubaneswar, Odisha.

#### 2. Job description & responsibilities

This position is at the Board level. The incumbent shall report to the Managing Director/ Chairman-cum-Managing Director. He shall also act as the Chief Load Dispatcher. He shall be responsible for conducting the real time grid operation/support services and commercial activities. He shall also be responsible for HR functions, Finance & Legal activities of SLDC. He shall ensure compliance of all directions issued by RLDC to STU/Generating Companies/any other Licensee of the State. He shall also be responsible for management of State Grid Code, Regulatory affairs relating to System Operation and related matters of Indian Electricity Grid Code(IEGC).

#### 3. Eligibility

#### I. Age:

As on the date of advertisement - Minimum age will be 45 years & maximum age will be 57 years (for external candidates) & 58 years (for internal candidates).

#### II. Employment Status:
